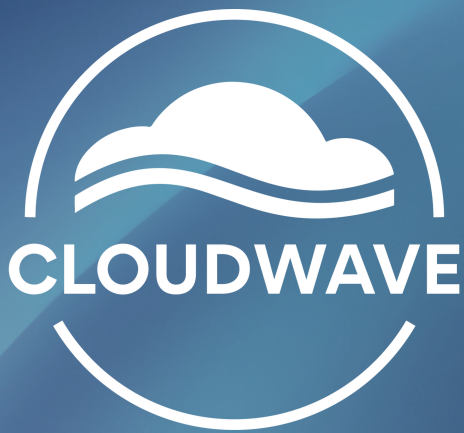

US Court of Appeals

CloudWave partnered with the U.S. Court of Appeals to modernize legal document review, improving the speed, accuracy, and consistency of processing thousands of filings each year. By integrating an AI-powered document digitization assistant into the court's Microsoft Dynamics system, CloudWave enabled automated data extraction, validation, and intelligent search—allowing staff to quickly surface key information and reduce manual review time.

Built with a human-in-the-loop approach, the solution keeps staff in control while streamlining repetitive tasks. All processing occurs securely within the court's infrastructure, ensuring full compliance with federal standards. The result is a more efficient, scalable review process that enhances accuracy while freeing staff to focus on higher-value legal analysis.

Small Business Administration (SBA)

Cloudwave's major enhancement initiative with the Small Business Administration (SBA) involved development of the JAAMS / [PAY.gov](https://www.pay.gov) Recoupment Data Integration. After the initial grant award process had been completed and the system moved towards operation and maintenance, the SBA needed to fulfill the critical functionality of determining when a recoupment of payment was required and tracking that recoupment from [Pay.gov](https://www.pay.gov) and/or JAAMS.

CloudWave designed and developed the bidirectional integration leveraging Mulesoft to automatically send recoupment data from [Pay.gov](https://www.pay.gov) and/or JAAMS to Salesforce SVOG and stored at the correct Funding Request record for a given grantee.

Document Digitizer AI

Doc Digitizer is an AI-powered document processing solution that scans handwritten or printed forms, IDs, insurance cards, invoices, and other records, then instantly converts them into structured digital data. The tool combines OCR and intelligent document recognition with configurable validation rules, allowing organizations to automate data entry, improve accuracy, and reduce the time spent on repetitive administrative work. It also includes human-in-the-loop review and secure deployment within a client's own environment, ensuring staff can verify results while maintaining control of sensitive information.

Grants Management

Our grants management tool is an AI-powered solution built to simplify and modernize the entire grant lifecycle, from application intake and eligibility review to award management and reporting. It automates manual tasks such as document collection, scoring, workflow routing, and status updates, helping organizations process applications faster while improving consistency and transparency.
